## Planning Tracks By Jim Wright

There are a variety of planning tracks in progress that will impact Ardmore Park. Geographically, planning foci are diverse and extensive. They include the entire City, Northwest Beltline Study Area, the Brookwood Alliance and our own specific Neighborhood.

The City of Atlanta has contracted with planning firm teams to develop a citywide comprehensive transportation plan. This effort will address such factors as land use and transportation linkages, opportunities for smart

growth, multi-modal opportunities -e.g. street cars, light rail, Marta expansion, shuttles, etc. As traffic congestion is reaching frenzied proportions in Atlanta, the development of such a plan is long overdue.

The Atlanta Beltline, Inc. has retained the engineering firm of Glatting Jackson. This professional company is contracted for developing a comprehensive plan for the Northwest Beltline Study Area, which includes Ardmore Park. Strong citizen participation is inherent in the planning

process. On 9/25/07, an important community meeting was held. Basically there was consensus from attendees that a new PATH extension should not go through Tanyard Creek Meadow. Rather, the preference was that the alignment should be on the west side of Tanyard Creek adjacent to the small playground that now exists there. Use of a variety of materials for the PATH other than concrete was also discussed.

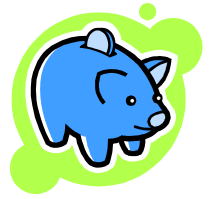
## Planning Tracks (continued)

The Brookwood Alliance is incorporated and organized with a set of bylaws. This umbrella organization includes Brookwood Hills Community Club Inc., Brookwood Civic Association Inc., Ardmore Park Neighborhood Association, Inc., Collier Hills Community Organization, Inc., Loring Heights Civic Association and Collier Hills North Civic Association. The Alliance continues to work with the Peachtree Corridor Task Force. Opportunities for new collective efforts by the organization will be addressed in the future as appropriate.

A Hospital Impact Analysis Plan is being developed by the Center for Quality Growth and Regional Development at Georgia Tech. This planning effort is the result of a generous grant from the Robert Wood Johnson Foundation. Under the direction of Dr. Catherine Ross, the study will examine the impact of hospitals on neighborhoods. Strong citizen participation will be associated with the study.

Of most immediate concern, a Plan for Ardmore Park was formulated by members of the Board of Directors. The Plan purpose is to provide a concise format outlining projects and actions of importance and consequence to the Neighborhood. Many of the elements included in the Plan were the result of recommendations by neighbors. If there are any suggestions for modifications or refinements to the Plan, please contact me. ## No Arch in the Park

Like our garden flowers that blossomed so beautifully in the Spring and then withered with the heat and drought of the Summer, the addition of the Mayflower Arch to our park has withered under the demands of the City of Atlanta. The final decision of the Ardmore Park Association committee attempting to locate this structure in the park and the board is to abandon the effort.

Julie Hall, Hank Schwab, Ben Darmer, and Susan Gworek, along with Jim Wright and the rest of the APA board concluded, after polling the neighborhood and with advice from neighborhood attorneys, that we could not meet the demands of the Parks Department. The requirement that we provide insurance for the Arch as well as the numerous other requirements to extend for a period of 50 years were just too much of a commitment for future neighbors.

What had appeared to be a great idea to retain this masonry monument as an architectural feature in the Ardmore Park encountered difficulties at the Parks Department from the very beginning. Parks first required an expression of support from the neighborhood. This we did. Then when we got ready to move the dismantled stones, Parks would not allow them to be moved to the Park without an agreement to maintain the structure.

As an interim step, Hank Schwab located the stones next to his home on Wycliff. Here they remain today. After months of waiting and negotiating, the Parks Dept presented a long list of requirements to APA. In short, these requirements read that Ardmore Park pay for everything however Parks will direct everything. It was clear to the committee that the City did not want the Arch in the park and would make requirements so difficult to meet that the neighborhood would eventually abandon the project, which we have. Mark Riley, the developer of the Brookwood condo project and benefactor for moving the Arch, has not decided the next step. He has sent word that he's exploring other locations, but no decision has been made yet.

It is disappointing that so much effort was made and we have so little results to show for the effort. Everyone can be thanked for their many hours of work to try and make this project successful. For now, we will all continue to enjoy our beautiful neighborhood and park, but without the Arch.

NPU-E has been very busy the past six months. At our August meeting, we added the Atlantic Station Neighborhood Association to the NPU-E. Since Atlantic Station is such a thriving and successful community, they requested and received representation on the board. We now have (11) neighborhoods that comprise our NPU: Ansley Park Civic Association, Ardmore Park Neighborhood Association, Atlantic Station, Brookwood Civic Association, Brookwood Hills Community Club, Inc., Georgia Tech, Home Park Community Improvement Association, Loring Heights Civic Association, Midtown Neighborhood Association, Sherwood Forest Civic Association and the Marietta Artery Association. These neighborhoods represent a significant area of the explosive intown growth currently taking place in Atlanta.

We address so many issues at our monthly meeting that we have extended the time for this meeting. We meet monthly at the Peachtree Christian Church from 6:30 PM—9:00 PM. Some of the issues with which we are dealing are related to the Beltline Overlay District that includes our entire neighborhood. This overlay allows for a different set of guidelines relating to development projects which occur within the overlay.

I encourage residences to take time on the 1st Tuesday of each month to come and see the NPU-E in action. It is community action at its finest.

### 301 Ardmore Circle

In July, Michael Rothman, Chairman for NPU-E, received a package from the offices of the Zoning & Development Services indicating that there had been a Special Administrative Permit (SAP) applied for ,



within the NPU-E. Michael contacted Steve Fairley, the NPU-E representative for Ardmore Park, since the SAP in question was for a parcel of land within the Ardmore Park neighborhood and delivered the SAP to Steve. Upon investigation, we learned that this SAP was applied for because our neighborhood is within the Beltline Overlay District.

The parcel in question is known as 301 Ardmore Circle. This property currently consists of rental properties. The Lane Company, applicant for the SAP, has plans to build (36) three and four story townhomes on the 3.2 acre parcel.

Copies of the SAP, along with preliminary plans, were delivered to the Land Use Committee members in early August for their review. The Land Use Committee met with the developer and their design team August 21<sup>st</sup> to review their plans. The Land Use Committee was very impressed with their proposal and felt that it would be a very nice addition to our neighborhood.

The Land Use Committee requested that since this site is heavily forested, that the developer takes all means to maintain as many of the trees as possible. They are working with Aborguard, a local arborist, to develop a Tree Preservation Plan for the project. They also indicated that they are considering building “Earth Craft” homes which are ecologically sensitive designs. The price point for these units will be between \$700,000 and \$900,000.

The schedule of development is still being finalized along with the plans, but the developer has indicated that they will close on the property in October 2007 and will assist the current tenants in finding housing alternatives through the end of the year. They would like to begin earth work in February 2008 and begin occupancy in the Fall of 2008.

## Security Update

### Security at Ardmore Park remains good.

To date, we have not experienced any security problems as a result of the construction of the Brookwood at the top of 28th Street.

In addition, we have become members of the Citizens' Advisory Committee, which is a group of neighborhoods in our area. The Atlanta Police Department provides the group with weekly police reports for our area, and those I forward on to you via e-mail.

We are also looking into joining **Neighborhood Watch**, which essentially is a system of neighborhood awareness and communication plus the addition of signs. Criminology literature reveals that the mere existence of neighborhood watch signs reduces criminal activity in an area.

Currently, Ardmore buys about 40 hours of police patrol each month. Our security offices are Barry Miller, Justin Andersen, Steve Shultz, Steve Seawell, and Marion Battle, and they patrol our neighborhood at random times.

We could, of course, double the amount of patrol hours if everyone paid security dues. Unfortunately, only about half of our neighborhood does so.

Dues are set at \$150 a year for people who live in a house and \$80 a year for those who live in apartments or condos. However, any amount is not only acceptable but well appreciated, and all the money goes directly to buying patrol hours. There are no other expenses, not even postage.

Finally, don't forget our telephone voice mail number. It is **404/367-9895**. Our patrolmen pick up our messages every day, and you should call if you want them to know you are out of town or if there is something you'd like them to watch out for such as a constant parking problem area.

For any immediate concern, always call 911. Sgt. Barry Miller emphasizes again and again that you should never hesitate to call 911. To reach a security patrol officer directly call **404/224-3321**.
